If NWCS cancels, your deposit and fee payment will be returned in full. Your entire retreat payment is forfeited if you cancel after **Feb 2nd**.

Waiver and Release Form
COVID Information and Requirements for Participants
Northwest Collage Society Retreat 2022

1. We will be complying with all Washington State COVID mandates in effect at the time of our event at Warm Beach Conference Center.
2. All participants must be fully vaccinated and provide a copy of their COVID Vaccination card to the Retreat Coordinator (Wendy James) **before January 28, 2022**. Anyone not providing proof of vaccination will not be allowed to register or participate in the retreat.
3. Masks covering mouth and nose are required to be worn inside the Maple Leaf Workroom and the Dining Room when not eating or drinking. Masks are optional outdoors. Work tables will be appropriately spaced for social distancing in the Maple Leaf Workroom.
4. We have been informed that all Warm Beach Conference Center staff are vaccinated and will be wearing masks and gloves during dining service. The dining room will be set up cafeteria style with plated meals offered at the end of a line and staff working behind plexiglass. Our groups' dining tables (identified with purple markers) will be distanced from any other groups' tables. Two other groups are scheduled to be on the campus at the same time as our weekend retreat.
5. **Waiver and Release:** Despite the foregoing precautions, participants attending the Northwest Collage Society's Retreat will nevertheless face some risk of contracting Coronavirus Disease (COVID). Warm Beach Conference Center is not a closed campus and its staff does not supervise the behavior of individuals who are on site. The Northwest Collage Society will not provide any insurance coverage for participants during this event. By signing this form, each participant agrees that all risks associated with attending the Retreat are voluntarily assumed and that the Northwest Collage Society is not and will not be liable for any injury to participants as a result of illness, including COVID, or accident, any property damage or loss, or any expenses or claims arising from or relating to the Retreat.

Adult Event - Permission to Participate and Release of Liability

Release/Participation: I am the participant, and with permission, I voluntarily participate in Warm Beach Camp activities including transportation.

I understand that this release includes any claims based on negligence, action or inaction of Warm Beach Camp, its employees, board of directors, volunteers, or guests.

Consent for Medical Treatment: I give permission for the Warm Beach Camp staff or volunteer nurse to follow the physician's standing orders for my care and treatment. I give permission to the physician selected by Warm Beach Camp to provide emergency medical treatment for me and to transport me to an emergency center for treatment. I understand that this emergency care may require the physician to hospitalize, secure proper treatment for, and to order injections, anesthesia, or surgery for me, the camper named on this form. I understand that it is my responsibility to notify the appropriate person should an injury occur.

I acknowledge that I have read and understand this entire Waiver of Liability and Release, and I agree to be legally bound by it.

Insurance: I understand that Warm Beach Camp does not provide any primary accident or health insurance for campers and guests and further understand it is my responsibility to provide such coverage.

Property Loss: Warm Beach Camp is not responsible for personal property lost, damaged or stolen while using Warm Beach Camp facilities, including parking lots, or participating in Warm Beach Camp programs.

Photograph Permission: I give permission for Warm Beach Camp to use, without limitations or obligation, photographs, film footage or tape recordings which may include my or my child's image, voice, or artwork for the purposes of promoting or interpreting Warm Beach Camp's programs.
