Entrants must be current NWCS members in good standing (dues must be paid) for the 2022/23 year.

- Member fee: Non-refundable entry fee is \$25 for one-to-three entries. Pay online (no later than 9/20/22). Pay by check (postmark by 9/20/22) made payable to Northwest Collage Society. Send checks to John Arbuckle, 4309 226<sup>th</sup> Pl. SW, Mountlake Terrace WA 98043.
- 2. All work must be for sale. The City of Mukilteo shall remit to the artist the net proceeds from the sale, less 25% and applicable sales tax within 30 days after closing of exhibit.
- 3. The Gay Jensen Award, given for innovation, will be awarded at this show.
- 4. Entries must be original, entirely created by the entrant, and not shown in a previous NWCS exhibit.
- 5. All entries must be collage, defined as: an artistic composition made of various materials (e.g., paper, photographs, paint) glued onto a supporting surface.
- 6. Size restrictions: Maximum dimensions 40x40 inches. (Dimensions do not include the frame.) Weight not to exceed 12 lbs.
- 7. Plexiglass is required for all frames w/ glass measuring greater than 14" in any direction.
- 8. White, off-white or black mats only; no mats or frames required for wrap around canvas.
- 9. All work must be hung with wire that is placed 1/3 of the way down from the top of the artwork. No sawtooth hangers.

10. The City of Mukilteo will not accept artwork that the City determines to be inappropriate or incompatible with the Public Uses Association. Inappropriate or incompatible art, as deemed by the City, the Parks & Arts Commission & the Visual Arts Commission is: political art, sexually suggestive art, religious art, or depicting nudity.

In the description section, <u>please write</u> <u>1-2 sentences about the narrative of each piece</u>. This will appear as a public statement at the gallery.

He gave an excellent program at our 6/21/22 NWCS meeting.
